#### Qualification period: August-December 2022

Q: Who can qualify for this award?

Q: If I have never been a Director before, can I step up to a Director using the Fast Track?

Q: Can a Director who stepped down prior to January 2022 participate in the Fast Track program?

Q: Can I achieve the qualifications in one month?
